We may process the following types of personal data:

3. Why Do We Process Your Personal Data?

We process personal data for the following purposes:

- Responding to inquiries and requests
- Maintaining business relationships
- Performing contracts and delivering services
- Organizing meetings, projects, and collaborations
- Improving our website and services
- Protecting our systems and website
- Complying with legal obligations

As an aviation consultancy and project development company, AirportCreators may also process business contact information to facilitate airport-related projects, innovation initiatives, stakeholder engagement, and industry collaborations.

4. Legal Basis for Processing

We process personal data only where there is a valid legal basis, including:

- Your consent
- Performance of a contract
- Compliance with a legal obligation
- Legitimate interests of AirportCreators, such as relationship management, communication, business operations, service improvement, and website security

5. With Whom Do We Share Personal Data?

AirportCreators does not sell personal data to third parties.

Personal data may be shared only with:

- IT and hosting service providers
- Suppliers supporting our services
- Professional advisors, such as accountants and legal counsel
- Government authorities when legally required

Where necessary, AirportCreators enters into appropriate data processing agreements with parties that process personal data on our behalf.

6. Transfers Outside the European Economic Area

If personal data is processed outside the European Economic Area (EEA), we ensure appropriate safeguards are implemented in accordance with GDPR requirements.

7. Retention Periods

We retain personal data only for as long as necessary for the purposes for which it was collected, unless a legal retention period applies.

After the applicable retention period has expired, personal data will be securely deleted or anonymized.

8. Cookies

Our website uses only functional cookies that are necessary for the proper operation and security of the website.

We do not use tracking, profiling, or marketing cookies without your consent.

9. Security

AirportCreators implements appropriate technical and organizational measures to protect personal data against loss, misuse, unauthorized access, disclosure, or alteration.

These measures include:

- Secure SSL connections
- Access restrictions
- Secure data storage
- Regular monitoring of our systems

While we make every effort to protect personal data, no system can guarantee complete security.

10. Your Rights

Under the GDPR, you have the right to:

- Access your personal data
- Correct inaccurate personal data
- Request deletion of your personal data
- Restrict processing
- Object to processing
- Receive your data in a portable format
- Withdraw consent at any time
